Description of Permitted Activity: To construct 300 square feet of swimming pool, and 132 square feet of coping, located approximately 195 feet from wetlands; to construct 288 square feet of pool house located approximately 232 feet from wetlands; to construct 48 square feet of outdoor shower located approximately 234 feet from wetlands; to construct 84 square feet of covered pool house entry located approximately 230 feet from wetlands; to construct approximately 115 square feet of steps, located, at their closest point, approximately 181 feet from wetlands; to construct 259 square feet of walks located approximately 230 feet from wetlands; to construct 704 square feet of patio, located 190 feet from wetlands; to remove an existing wall and steps, in order to allow for pool construction located approximately 195 feet from wetlands; to remove approximately 64 cubic yards of soil, in order to construct the pool; to install pool equipment located approximately 232 feet from wetlands; to install a pool drywell located approximately 224 feet from wetlands; to install a water line connection, to the pool house, located approximately 171 feet from wetlands; to abandon the existing septic system, by pumping the system clean and backfilling the system with clean sand and/or by removing the system, in accordance with Suffolk County Department of Health Services (SCDHS) requirements, located approximately 210 feet from wetlands; to install a new septic system, including one (1) 1,500 gallon septic tank and two (2) 8 foot diameter x 8 foot deep cesspools, with traffic bearing slabs and cast iron covers to grade, in accordance with SCDHS requirements, located approximately 230 feet from wetlands; to relocate part of an existing water service line located approximately 250 feet from wetlands; and to install a clean-out on the new septic line located approximately 200 feet from wetlands; at existing residentially developed property, fronting Wooleys Pond and containing town regulated tidal wetlands, in North Sea, Town of Southampton, Suffolk County, New York, **in accordance with the survey prepared by Robert A. Smith, dated October 12, 2007, last revised September 12, 2014.**

Description of Permitted Activity: To restore and enhance a bay bluff, by cutting and removing dead trees, on the bluff face and within the northeasterly corner of the parcel; by selective hand pulling and removal of invasive non-native Japanese knotweed; by removing existing mowed fescue lawn landward of the bluff face; by removing existing deteriorated wood landings and steps, both on the bluff face and on the seaward side of a timber bulkhead, at the toe of the bluff; by re-grading a portion of the bluff face; by planting native northern bayberry (*Morella pensylvanica*), native beach plum (*Prunus maritima*) and beach grass (*Ammophila breviligulata*); and by constructing new bluff access stairs, landings and railings, using untreated wood and light penetrable decking, in order to provide pedestrian access to the beach; as well as to install 4 foot high fences landward of the bluff face, and at least 50 feet landward of mean high water, at existing residentially developed property fronting Tiana Bay and tidal wetlands, where the shoreline is characterized by at least 100 feet of functional bulkhead, and the town's wetland permitting jurisdiction is limited to 50 feet landward of mean high water, in East Quogue, Town of Southampton, Suffolk County, New York, **in accordance with the "4 Squires Schematic Bluff Improvement Plan", as prepared by R/F Landscape Architecture, dated November 01, 2013, last revised October 06, 2014.**
