**TOWN BOARD RESOLUTION 2021-210**

**Notice of Public Hearing to Accept Public Comment on the Draft Plan and Recommendations in Conformance with New York Executive Order No. 203**

WHEREAS, by Resolution 675 of 2020, in an effort to continue the review of our Police Departments internal policies and procedures and in response to New York State Governor's Executive Order 203, The Town Board of the Town of Southampton established the Community Law Enforcement Review Committee, ("CLERC") chaired by Town of Southampton Supervisor, Jay Schneiderman and Southampton Police Department Chief, Steven Skrynecki; and

WHEREAS, pursuant to New York State Police Reform and Reinvention Collaborative Guidance Documents, such committee was comprised of local elected officials, clergy and stakeholders within the community who undertook a comprehensive review of current police force deployments, strategies, policies, procedures and practices, engaged with the public-at-large and developed a Draft plan and recommendations relative to the Town of Southampton Police Department for the purpose of enhancing community trust, transparency and optimal community-centric policing relative to current practices, policies, training, programming and outreach; and

WHEREAS, Since the passage of said Resolution and in furtherance of Executive Order 203 objectives, the CLERC committee engaged in bi-monthly meetings which consisted of presentations and committee discussions, sub-committee meetings, public-at-large surveys and listening forums, a youth forum and law enforcement forum; and

WHEREAS, at the conclusion of this process, the Town Board is required to ratify said document and authorize the Supervisor to sign a certification that such process and ratification pursuant to New York State Executive Order 203 and New York State Police Reform and Reinvention Collaborative Guidance Documents have occurred; and

WHEREAS, such Certification will ultimately be filed with New York State Division of the Budget by April 1, 2021; and

WHEREAS, at the end of this process, the Town Board of Southampton is hereby desirous of adopting the Draft Plan and concurrent Recommendations which it shall consider; and

WHEREAS, in furtherance of these efforts and in conformance with New York State Guidance documents, the CLERC wishes to publish The Draft Plan and concurrent Recommendations on the Town of Southampton website at [www.southamptontownny.gov](http://www.southamptontownny.gov) for the purpose of receiving further public-at-large comment prior to its adoption;
