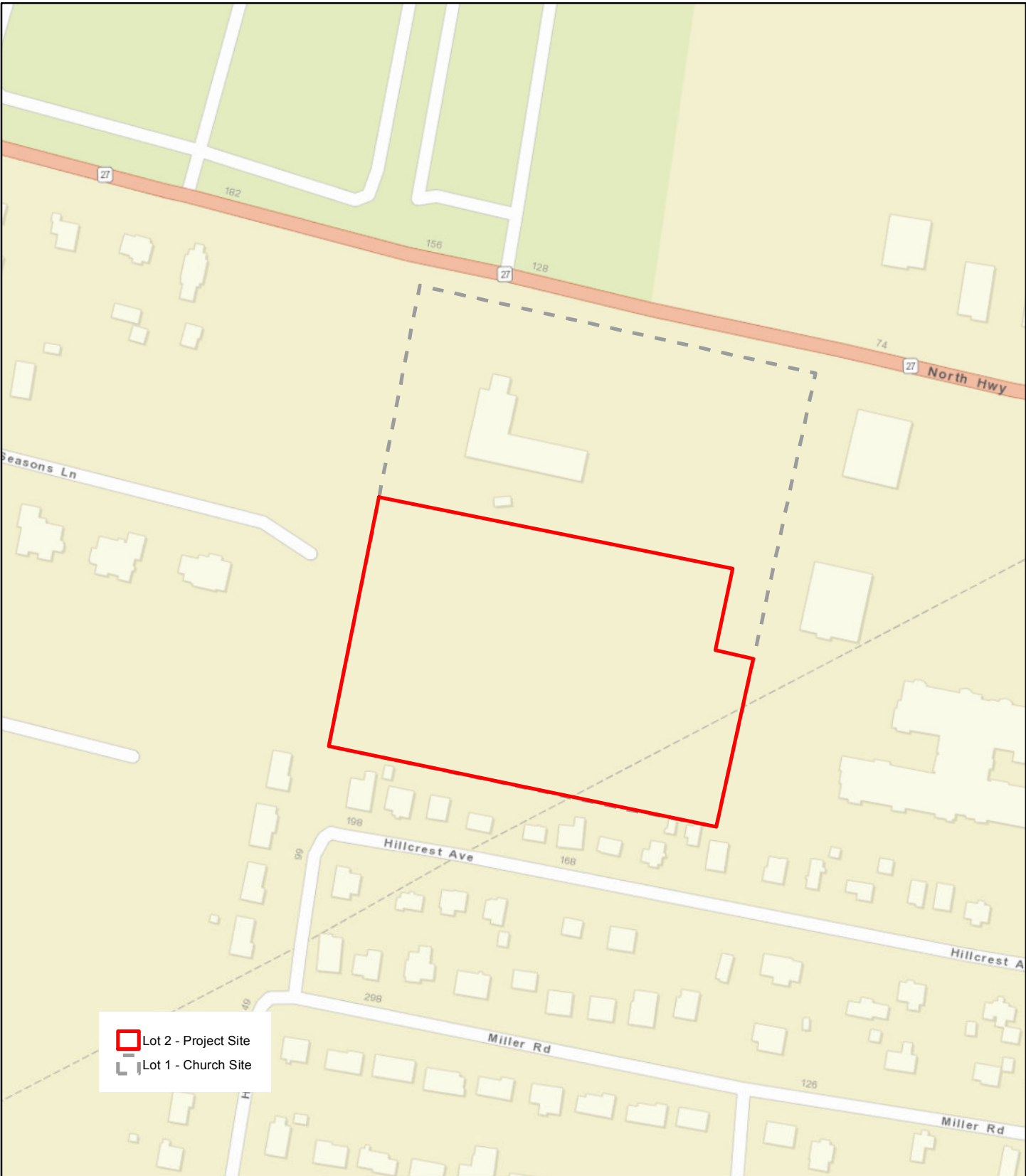

### **Brief Description of the Proposed Action**

The proposed project involves a two-lot subdivision of an overall 9.48-acre site presently zoned in the R-20 district, and subsequent rezoning and redevelopment of one of the two lots created, with a 60-unit 100% affordable multi-family apartment complex.

The subject property located on the south side of Suffolk County Route (CR) 39 (Sebonac Road), abutting the southeastern terminus of Seasons Lane in the Town and Village of Southampton. The address of the site is 130 County Road 39. The northern portion of the property is occupied by the Southampton Full Gospel Church, and the majority of the site is wooded and undeveloped.

The proposed project will subdivide the property between the existing church on the northern portion (4.48 acres; designated Lot 1) and the wooded southern portion of the property (5.00 acres, designated Lot 2). The applicant is proposing a change of zone for Lot 2 from R-20 to Multi-Family-44 (MF-44) for the multifamily residences. Lot 1, the 4.48 acres occupied by the church, will remain undisturbed and will not be rezoned. Access to Lot 2 will be obtained through an easement through Lot 1 to Sebonac Road.

The entire property is presently owned by the Southampton Full Gospel Church. Upon the subdivision approval, Lot 1 will continue to be owned by the church, and Lot 2 will be transferred to Concern Southampton LLC (an affiliate entity of the applicant, Concern for Independent Living, Inc.), which will develop the project. The project has received Low Income Housing Tax Credit from NYS Homes & Community Renewal.

Lot 2 is proposed to be developed with a 60-unit 100% affordable multifamily apartment complex. Six (6) two-story, apartment buildings containing 10 units each (mix of one- and two-bedroom apartments) will be constructed throughout the site and a 5,000 square foot (SF) community building is proposed on the east-central portion of the property. Vehicle access is proposed from CR 39 to the north, and an emergency access is planned through Hillcrest Terrace to the southwest.

The Town Code requires a minimum of 111 on-site parking spaces, which is the number of spaces that will be provided. In conformance with Suffolk County Sanitary Code Article 6, an on-site sewage treatment plant (STP) is proposed in the southeast portion of the site and will include landscaped buffers. All sanitary wastewater generated by the residences will be conveyed to and treated at this STP; the church (i.e., Lot 1) will not be connected to this STP, but will continue to be served by its on-site septic system. Approval from the Board of Review, Suffolk County Department of Health Services will be required. Remaining portions of the site will consist of retained natural vegetation and landscaping. No structures are proposed within the Village of Southampton portion of the property.
