**Part 2 is to be completed by the lead agency.** Part 2 is designed to help the lead agency inventory all potential resources that could be affected by a proposed project or action. We recognize that the lead agency’s reviewer(s) will not necessarily be environmental professionals. So, the questions are designed to walk a reviewer through the assessment process by providing a series of questions that can be answered using the information found in Part 1. To further assist the lead agency in completing Part 2, the form identifies the most relevant questions in Part 1 that will provide the information needed to answer the Part 2 question. When Part 2 is completed, the lead agency will have identified the relevant environmental areas that may be impacted by the proposed activity.

If the lead agency is a state agency **and** the action is in any Coastal Area, complete the Coastal Assessment Form before proceeding with this assessment.

**Tips for completing Part 2:**

- Review all of the information provided in Part 1.
- Review any application, maps, supporting materials and the Full EAF Workbook.
- Answer each of the 18 questions in Part 2.
- If you answer “**Yes**” to a numbered question, please complete all the questions that follow in that section.
- If you answer “**No**” to a numbered question, move on to the next numbered question.
- Check appropriate column to indicate the anticipated size of the impact.
- Proposed projects that would exceed a numeric threshold contained in a question should result in the reviewing agency checking the box “Moderate to large impact may occur.”
- The reviewer is not expected to be an expert in environmental analysis.
- If you are not sure or undecided about the size of an impact, it may help to review the sub-questions for the general question and consult the workbook.
- When answering a question consider all components of the proposed activity, that is, the “whole action”.
- Consider the possibility for long-term and cumulative impacts as well as direct impacts.
- Answer the question in a reasonable manner considering the scale and context of the project.



This Notice is issued pursuant to Article 8 of the New York State Environmental Conservation Law and Part 617 of the New York State Code of Rules and Regulations (collectively, "SEQRA").

The Town Board of the Town of Southampton (the "Board") as Lead Agency, upon review of Parts 1 and 2 of the Full Environmental Assessment Form (the "EAF") prepared in connection with this matter, has determined that the Proposed Action described below will impart potentially large and significant impacts on the environment and that a Draft Environmental Impact Statement be prepared.

**1. NAME OF ACTION:** "Concern Southampton"

**2. SEQR STATUS:** Type I Action

**DESCRIPTION AND LOCATION OF ACTION:** The proposal involves the premises located at 130 County Road 39, within the hamlet of Tuckahoe, in the Town of Southampton.

The proposed application consists of two separate lots, located on the south side of County Rd 39, within the Hamlet of Tuckahoe and the Village of Southampton. Specifically, the total area of the two parcels is approximately 9.48 acres (412,948.8 sq. ft.), 9.28 acres (SCTM# 900-159-2-25.7) are located within the Hamlet of Tuckahoe, the remaining .20 acres (SCTM#: 904-4-1-74.9), fall within the jurisdiction of the Village of Southampton.

The petition requests rezoning from the existing Residence-20,000 square feet (R-20) classification to Multifamily (MF-44) and seeks an increase in residential density under Town code section 330-8 to increase the permitted density on the parcel from six (6) units per acre to twelve (12) units per acre in exchange for 100% affordable community benefit rental housing.

As defined by the applicant:

*"The Concern Southampton promises to be a design for a moderate-income affordable residential development with provisions for veterans and the disabled. One hundred percent (100%) of the rental housing shall be community benefit units, in perpetuity which are defined in Section 216-2 of the Southampton Town Code."*

In tandem with the zone change the applicant would seek a two lot subdivision, so that the first lot fronting on CR39 would be approximately 4.48 acres and will maintain the existing one story Gospel Church; identified herein as Lot 1. The proposed second lot, Lot 2, would be approximately 5.00 acres and is the subject of the proposed zone change application where the applicant seeks to construct five (5) two- story residential apartment buildings, two of which are comprised of fourteen (14) units, one building with twelve (12) units and two buildings with ten (10) apartments for a total of sixty (60) units.

**3. REASONS SUPPORTING THE DETERMINATION:** The Application, for SEQRA purposes, has been evaluated by this Board solely in accordance with the criteria for Determining Significance as contained in 6 NYCRR §617.7(c) (individually and collectively, the “SEQRA Criteria”) and thorough review of Parts 1 and 2 of the Full Environmental Assessment Form (FEAF), all for the purpose of assessing its potential environmental impact. To aid in this review, as part of the submission materials the applicants submitted an expanded Environmental Assessment prepared by the Environmental Consulting firm Nelson Pope & Voorhis LLC (dated March 2021) and the Town secured Dunn Engineering Associates for the review of the Traffic Impact Study Dated May 2020.

- Using the information from Part 1, the Town Department of Land Management has answered questions 1 through 18 on Part 2.
- Using the Part 2 tools, it was determined that there would be no impact to the environmental resources evaluated in Questions 2, 5, 6, 8, 9, 10, 11, and 12. These were all checked as “No” or “no or small impact may occur” on Part 2.
- However, it was determined that questions 1 (Impact on Land); 3 (Impact on Surface Water); 4 (Impact on Groundwater); 7 (Impact on Plants and Animals); 13 (Impact on Transportation); 14 (Impact on Energy); 15 (Impact on Noise, Odor and Light); 16 (Impact on Human Health); 17 (Consistency with Community Plans) and 18 (Consistency with Community Character) would need further elaboration so these were checked as “moderate to large impact may occur” on Part 2, and evaluated below as the narrative of Part 3 for the purposes of making a determination of significance.

### **IMPACT ON LAND**

The Town Board finds potentially large impacts associated with land resources which may be an impact to the following:

- *The project involves developing an existing wooded property to five (5) two-story residential apartment buildings totaling 60 units, with a two-story clubhouse and recreational area.*
- *Impact of additional use of the property is above the current zoning designation.*
- *Comparison of existing intensity of use and proposed use of multi-family.*
- *Construction Phasing Plan. Construction Plan should include, but not be limited to, truck circulation, staging areas, storage of materials, erosion control, noise and dust control, etc. Construction periods should be limited to Mon-Fri during normal business hours and should account for traffic mitigation strategies.*
- *Proposal involves the clearing of 4 acres of woodland (approx. 86% of Lot 2).*

### **IMPACT ON SURFACE WATER**

The Town Board finds potentially large impacts to surface water which may be an impact to the following:

- *Proposal involves the clearing of 4 acres of woodland (approx. 86% of Lot 2) and will create surface parking and impervious surface areas that may further impact impaired waterbodies within the Village watershed.*
- *The proposed density requires the construction of a new wastewater treatment facility.*
- *Discuss or compare the nitrogen from the as of right uses vs. the STP, and how the expansion area designed for the STP will affect the future yield of the front (church) parcel.*

### **IMPACT ON GROUNDWATER**

The Town Board finds the potential impact to groundwater will be the following:

- *The proposed action may include or require wastewater discharged to groundwater.*
- *Impact of the STP on groundwater.*

### **IMPACT ON PLANTS AND ANIMALS**

The Town Board finds the potential impact on plants and animals will be the following:

- *Proposed action will result in the clearing of 86% of natural vegetation on the site.*

### **IMPACT ON TRANSPORTATION**

Related to the potential impact on Transportation, the applicant provided a traffic analysis by Nelson Pope Voorhis which was forwarded for peer review to the Town's consultant, Dunn Engineering Associates, P.C. Consulting Engineers. In a report dated September 4, 2020, Ronald Hill, P.E. indicated numerous concerns related to traffic and the lack of access to North Sea Road.

Following Dunn Engineering's review, Nelson Pope released a Memorandum dated February 8, 2021 responding to each of the noted comments. The applicant has satisfied several of the concerns identified, however, the Town Board finds the potentially large impacts on transportation will impact the following:

- *Discuss applicant's methodology for Saturday data which is typically reserved for the Western Towns of Suffolk County.*
- *Discuss underestimated growth factors.*

- *Include data, and discuss conclusions and speculation of future traffic trends due to COVID-19.*
- *Discuss comments from Suffolk County Department of Public Works (SCDPW) dated April 28, 2021, “While the traffic generation of the project may not impact existing east bound traffic patterns regarding right turns, left turns may have a significant impact on existing eastbound traffic.*
- *Discuss access to CR39 and alternative access points.*
- *Discuss Comprehensive plan recommendation as it relates to minimizing the number of access points along County Road 39.*
- *Traffic analysis shall be completed with actual counts and shall include, peak number of trips per hour during the height of the summer season, and shall contemplate “right-in/right out” access only.*
- *The applicant should continue to seek potential cross-access to the site.*
- *Traffic analysis shall also include information and strategies to mitigate construction vehicles access to the site, specifically to avoid further impact to traffic on County Rd. 39 during peak hours.*

### **IMPACT ON ENERGY**

Question 14 (Impact on Energy) was checked in order to further elaborate on the Town’s policies toward energy efficiency. The Town Board of the Town of Southampton is committed to energy efficiency, especially in new construction, in order to reduce peak loads for PSEG capacity planning on the South Fork. The applicant has indicated that they will only make green building/energy efficient design decisions during the site plan application process, which does not give the lead agency enough information related to energy usage from the proposed density of housing.

Beginning with the 1970 Master Plan, the Town Board of the Town of Southampton has taken a proactive leadership role in enacting legislation and/or programs that promote sustainability, and energy conservation. This long standing precedent of stewardship has led the Town towards environmentally conscious development, moving the community to the forefront as a model of sustainability in the State of New York. Such environmental protection and sustainable agendas have continued through subsequent adopted plans, specifically the Town of Southampton Sustainability 400+ Plan. Therefore, the Town Board finds the potentially large impacts on energy will impact the following:

- *Discuss inconsistencies with Sustainability Plan energy goals and objectives.*
- *Discuss green building design alternatives.*
- *Discuss the proposed in relation to the Town’s commitment to one hundred percent (100%) community electricity through renewable energy by 2025.*

### **IMPACT OF NOISE, ODORS OR LIGHT**

The Town Board finds the potentially large impact on noise, odors or light will be the following:



- *The proposed action may result in an increase in noise, odors and outdoor lighting.*
- *The proposed action may produce sound above noise levels established by local regulations.*
- *Impact of operating noise exceeding the local ambient noise levels for noise outside of structures.*
- *Impact of noise during site construction.*
- *Impact of noise during the occupancy of the 60 rental units, and on-site recreational facility.*
- *Submission of noise study.*
- *The proposed action may result in lighting creating sky-glow brighter than existing area conditions.*
- *Impact of outdoor and ambient lighting on the neighboring area from the parking areas and the recreational areas.*

### **IMPACT ON HUMAN HEALTH**

The Town Board finds the potentially large impact on human health will be the following

- *The proposed action involves the construction of a Solid Waste Management facility (STP).*
- *Information on the quantity of the solid waste generated from the construction of the project and the resulting operation of the project, including processing and disposal information.*
- *Impact of the STP on groundwater.*
- *Potential impacts on human health related to traffic impacts, including the impact on air quality.*

### **CONSISTENCY WITH COMMUNITY PLANS**

The Town Board finds the potentially large impacts resulting from inconsistency with community plans will be an impact to the following:

- *The proposed project is not consistent with adopted land use plans (Corridor Plan).*
- *The proposed action's land use components may be different from, or in sharp contrast to current surrounding land use pattern(s).*
- *The proposed action is inconsistent with County plans, or other regional land use plans.*
- *The proposed action may cause a change in the density of development that is not supported by existing infrastructure or is distant from existing infrastructure.*
- *Potential impact with the existing Zoning Code for the Town of Southampton and the Town of Southampton Comprehensive Plan Update.*
- *Proposed action is inconsistent with suitability elements referenced within the Sustainability Plan.*
- *Discuss anticipated development with regards to Lot 1 to avoid segmentation.*

- *Provide an analysis of the anticipated energy consumption or the potential strain development may have on existing energy facilities. If found to be substantial, incorporating further green building initiatives into the design and utilizing alternative energy sources would constitute a mitigation technique and also a public benefit.*

### **CONSISTENCY WITH COMMUNITY CHARACTER**

The Town Board finds the potentially large impacts resulting from inconsistency with community character will be an impact to the following:

- *The proposed action may create a demand for additional community services, including police, fire, ambulance and education facilities.*
- *Proposed action is inconsistent with the character of the existing natural landscape.*
- *Proposed action is inconsistent with the single family residential nature of the area.*
- *Specify exact terms of the PILOT.*
- *Discuss school children enrollment as of right vs proposed.*
- *Discuss measures to mitigate ascetics associated with 60 community support units differing from the single family residential character.*

### **Recommendation:**

Work sessions were held on the applicant's change-of-zone proposal on February 7<sup>th</sup> 2019 and August 1<sup>st</sup> 2019, where the Department of Land Management prepared a pre-submission report to the Town Board entitled "Multi-Family Housing at Southampton Full Gospel Church." This began the analysis of the existing zoning vs. proposed zoning with regard to the surrounding uses, neighborhood character, and consistency with comprehensive plans. Following the pre-submission report and subsequent work sessions, the Town Board voiced concerns with regards to cross-access to Season's Lane and Hillcrest Terrace. Siting inconsistency with community character, the Town Board advised the applicant to seek alternative cross-access with the adjacent parcel to the east, the Hamptons Center for Rehabilitation and Nursing at 64 County Rd 39A.

Currently, the applicant has been unable to secure alternative cross-access, resulting in a proposed single access point on County Road 39 to serve the 60 unit development. As identified in the Full Environmental Assessment form, Part Two - Questions 13 and 17, the applicant's proposal lacks consistency with recommendations from the Town's Comprehensive Plan, specifically calling for the number of access points along County Road 39 to be minimalized not increased.

The subject development will result in the increase of traffic generated from the site when compared with the existing zoning designation. Traffic volume and patterns shall be analyzed and as the project is on CR-39 and near the intersection with North Sea Rd, the Suffolk County Department of Public Works (SCDPW) comments must be addressed. It appears from the SCDPW

letter dated April 28, 2021, proposed access shall be limited to right hand turns in/right hand turns out, only.

As indicated within Questions 14 and 17, the applicant should address inconsistencies found within the Comprehensive plan which extend to specific goals, objectives and recommendations referenced within the Southampton 400 + Sustainability Plan.

Additionally, since the proposed project includes the subdivision of land, which will create Lots 1 (Full Gospel Church), and 2 (subject project), the development potential of Lot 1 should be evaluated as part of this project to avoid segmentation under SEQRA. The intent of SEQRA is to ensure review of a proposed project in its entirety: "Considering only a part, or segment, of an overall action is contrary to the intent of SEQR."

Therefore, the proposed application warrants further analysis and discussion with the consideration of sustainability elements, segmentation, traffic circulation, specifically no left turns from the Country Rd. 39 single access point which would be appropriately addressed in a Draft Environmental Impact Statement (DEIS).
