RULES FOR GROUP USE OF RED CREEK PARK ACTIVITY CENTER AND/OR PICNIC PAVILION

*****Southampton Town may not be subjected to liability for personal injuries of those attending or hosting events while utilizing facilities*****

- Facility Use Permits are **NON-REFUNDABLE. CHANGE OF FACILITY / DATE WILL RESULT IN NEW PERMIT FEES. NO EXCEPTIONS!!!**
- **ABSOLUTELY NO ALCOHOL PERMITTED AT ANY TIME.**
- Only Town residents/taxpayers over 18 years of age may reserve the facilities. **MUST** show photo I.D. and proof of residency (**NO P.O. BOXES**).
- All decorations and garbage must be removed from facility at the end of the event.
- There are two time slots available: **10 am - 3 pm or 4 pm - 9 pm (Only one facility and one-time slot may be rented per day)**. Facility **MUST** be vacant for cleaning from 3 pm - 4 pm.
- Set-up and clean-up **MUST** be accomplished within the allotted five-hour time frame.
- Reservations can be made no more than **THREE MONTHS** in advance.
- Inflatables, jumpers, slides, pets, etc. are prohibited.

PAVILION ONLY (Approx. (8 picnic tables available)

- Gas grills only (**Charcoal Grills Prohibited**). No grills or cooking is permitted under the roof areas.
- Loud music is prohibited. **No** amplified music at any time.

ACTIVITY CENTER ONLY (Required: \$100 Refundable Security Deposit)** (Approx. (4) 48" kiddie height round tables, (10) 60" round tables, (6) 6' long tables, (2) 10' long tables & (90) metal folding chairs)

- Cooking equipment is **PROHIBITED** in the Activity Center at any time.
- The group is responsible for the following cleaning tasks:
 - Sweeping, mopping and cleaning the counter tops if the kitchen area is used
 - Setting up and taking down tables and chairs and returning them to the storage area
 - Sweeping and spot cleaning the activity room floor if needed
 - Removing garbage and placing it in the outside garbage cans
- Smoking is prohibited in the Activity Center at all times.
- **HELIUM BALLOONS**, rollerblades, bicycles & skateboards are **PROHIBITED** in the Activity Center.
- Loud music is prohibited. All sound **MUST** be contained within the Activity Center.
